In this connection, please find enclosed a copy of CGDA office letter dated 25/04/2019 and Min of Defence ID No : 8(24)/2016-D (Estt/Gaz) dated 08.04.2019 wherein it has finally been clarified that Officers of IOFS cadre who are in the functional SAG level (not by means of NFU) notwithstanding the fact that they are not HODs, are entitled to official car or higher rate of Transport Allowance in lieu of the official car as the case may be.


