BOOSTING EMPLOYMENT ACROSS SECTORS

The government has taken unprecedented steps to address the problems faced by the people, particularly, the migrant labourers who were subject to untold miseries due to Corona Virus (COVID-19) pandemic with some of them sacrificing their lives in the run up to their employment. The Labour Ministry proposed to develop National Database of the Unorganized Workers and migrant workers seeded with their Aadhaar cards.

The global spread of Corona Virus (COVID-19) followed by lockdowns has affected economies across the globe including India. COVID-19 has resulted in large number of migrant workers going back to their native places. The government has advocated for Aatmanirbhar Bharat, which is based on Economy, Infrastructure, System, Vibrant Demography and Demand to create jobs for the youth.

National Commission for Migrant Labour: NITI Aayog has constituted a sub-group to prepare a tangible National Action Plan to address issues related to migrant workers in the country. The Centre had enacted the Inter-state Migrant



Workmen (Regulation of Employment and Conditions of Service) Act, 1979. This Act has now been subsumed in the Occupational Safety, Health and Working Conditions Code, 2020. It provides for decent working conditions, minimum wages, grievances redressal mechanisms, protection from abuse and exploitation, enhancement of the skills and social security to all category of organised and unorganised workers including Migrant workers.

Pradhan Mantri Garib Kalyan Rojgar Abhiyan: The Centre has launched the Garib Kalyan Rojgar Abhiyaan of 125 days on 20th of June, 2020 with a resource envelop of 50,000 crore rupees to boost employment and livelihood opportunities for returnee migrant workers and similarly affected citizens in rural area, in the wake of COVID-19 pandemic. The objectives of the Abhiyan were to provide immediate employment and livelihood opportunities to the distressed, to saturate the villages

with public infrastructure and creation of livelihood assets to boost the income generation activities and enhance long term livelihood opportunities in some of the states. A total of 50.78 crore Person days employment has been generated during the Abhiyan with an expenditure of 39,293 crore rupees.

Aatmanirbhar Bharat Rozgar Yojana (ABRY) The Scheme has been launched with effect from 1st of October 2020 to incentivize creation of new employment along with social security benefits and restoration of loss of employment during COVID-19 pandemic.

Under the scheme; an employee drawing monthly wage of less than 15,000 rupees who was not working in any establishment registered with the Employees' Provident Fund Organization (EPFO) before 1st of October, 2020 and did not have a Universal Account Number or EPF Member account number prior to 1st of October 2020, is eligible for the benefit.

Further the scheme reduces the financial burden of the employers of various sectors/industries including

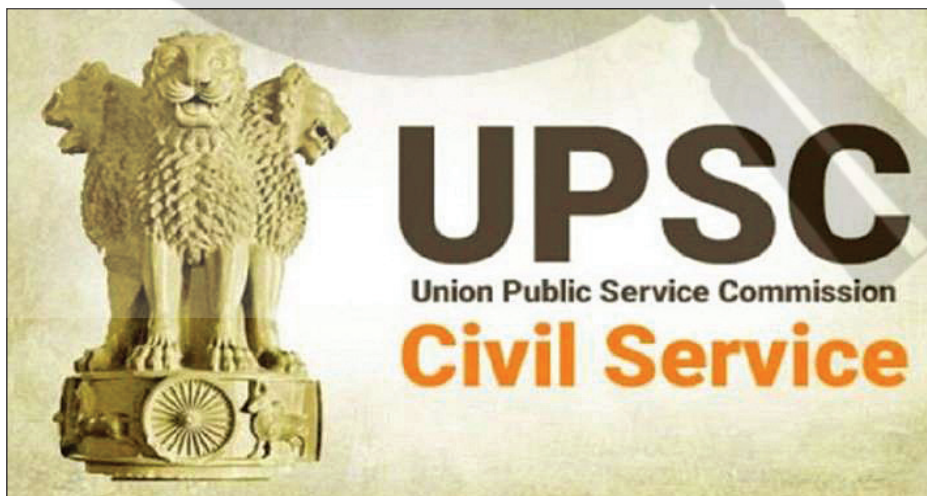
PREPARING FOR CIVIL SERVICES INTERVIEW

Part-II

When it comes to preparing for Civil Services (CS) personality test, popularly known as CS interview, the common question in the minds of aspirants is : how to prepare for it? Knowing little about the way it is conducted, the composition of the board, method of assessment of performance, allocation of marks and probable areas on which questions shall be raised, it is inevitable that a candidate who is going to present himself before the board develops anxiety, fear and mental blocks which may affect his performance adversely. Getting to know about the vital aspects of preparation is , thus, an imperative need.

How the interview session is conducted: In its notification, UPSC clearly mentions both the purpose and manner of the interview. It is quite



instructive to read UPSC guidelines in its published notification.

- I. UPSC, in its notification, states that " a candidate will be asked questions of general interest. The object of the interview/ personality test is to assess the personal suitability of the candidate for a career in public service by a board of competent, unbiased observers."
- II. "The technique of the interview/ personality test is not a strict cross-

examination but of a natural, though directed and purposive conversation which is intended to reveal the mental qualities of the candidate."

- III. "The interview/ personality test is not intended to be a test either of specialised or general knowledge of the candidate which has already been tested through their written papers. Candidates are expected to have taken an intelligent interest not only in their special subjects of academic

study but also in the events that are happening around them both within and outside their own state or country as well as on modern currents of thought and in new discoveries which should rouse the curiosity of well educated youth."

A close reading of the above instructions issued by UPSC removes all doubts and apprehensions about the interview. The major derivations from UPSC instructions are:

1. The interview seeks to assess whether a candidate is suitable for a career in public service. His traits of leadership, decision making capacity, social cohesion, balanced judgement, moral and intellectual integrity will greatly determine his suitability for public service.
2. The board, consisting of five members, is a competent and unbiased group of experienced experts which will be solely guided by objective criteria of a candidate's

- merit without any bias of any kind. Everyone is treated as equal before the board irrespective of his social, economic, academic background.
3. The keyword used by UPSC is "purposive conversation" during the interview session. By engaging you in a conversation, the board will encourage you to reveal your mental qualities such as mental alertness, critical powers of assimilation, clear and logical exposition, balance of judgement, variety and depth of interest,
- ability for social cohesion and leadership, intellectual and moral integrity.
4. Finally, UPSC notification makes it amply clear that current happenings in the state to which a candidate belongs, national and international happenings, current developments in health, trade, science and technology etc will be taken up during the conversation. Quite naturally, current affairs constitute a good part of the interview.

How the interview begins: When you enter the board, you

will find yourself standing before five senior, experienced members sitting opposite you.



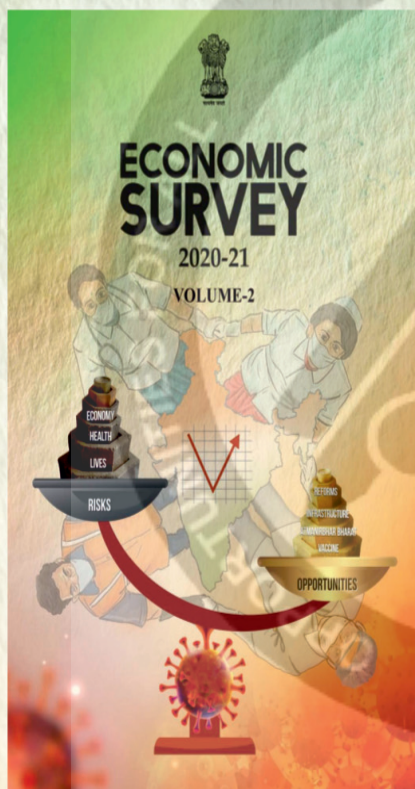
Of these, one will be chairman of the board, who happens to be one of the members of UPSC. Quite often, the chairman is a retired bureaucrat from IAS, IPS, IFS or some central service. Of the remaining four, two members happen to be from bureaucracy while two are domain experts. These four members come on invitation by UPSC to be a part of the board. Once you are asked to take your chair, the chairman will engage you in a short conversation for five to seven minutes mostly raising questions relating to your bio data, known as DAF or Detailed Application Form. Then, he will direct another member to put his questions before you. He may also raise some questions on certain aspects of information furnished by you in your DAF. Then he will ask questions relating to economics, governance, international issues etc. This trend will continue during the remaining part of the interview. In other words, different questions on economy, health, governance, etc will be posed by all members. Moreover, certain well known questions regarding your choice for civil services as a career, hypothetical questions like how you will act in a given situation, how will you tackle corona in your district if you are the district collector, are bound to be raised. During this kind of conversation, there will be situations where the member/members will disagree with you on your position, explanation. You must remember, it is part of the interview process and disagreement is designed to test your balanced responses.

How your performance is assessed? After you leave the interview room, the chairman will give his comments on your performance to other members. The other members will also submit their assessment of your

performance. Keeping in mind how they have been allocating marks to previous candidates, they will arrive at a certain allocation of marks to you. Rather than judging your performance on various specific yardsticks, they will judge you on the basis of your overall personality projection. A good performance is one in which you are able to convince the board with your crisp, precise answers and impress them with your personality traits. A bad performance is one where you appear unsure about your stand on an issue, or contradict yourself, or lack basic information expected of you. An average performance is one where in you are found to be a person of medium calibre lacking outstanding qualities.

Probable areas of questions: A proper understanding of the kind of questions being asked to majority of candidates in the

BOOSTING EMPLOYMENT ACROSS SECTORS

MSME and encourages them to hire more workers. Under ABRY, the Centre is providing both the employees' share (12% of wages) and employer's share (12% of wages) of contribution payable or only the employees' share.

Garib Kalyan Rojgar Abhiyaan: To boost employment and livelihood opportunities for migrant workers returning to villages, in the wake of COVID-19 outbreak, the Centre has launched Garib Kalyan Rojgar Abhiyaan on 20th of June 2020. It focuses on durable rural infrastructure and providing modern facilities like internet in the villages.

Deendayal Antyodaya Yojana: The Housing and Urban Affairs Ministry is implementing a Centrally-sponsored Scheme -- Deendayal Antyodaya Yojana - National Urban Livelihoods Mission to reduce poverty and vulnerability of urban poor households by enabling them to access gainful self-employment and skilled wage employment opportunities.

Pradhan Mantri Mudra Yojana (PMMY) has been initiated by the Government to facilitate self-employment. Under PMMY collateral free loans up to 10 lakh rupees, are extended to micro/ small business enterprises and to individuals to enable them to setup or expand their business activities.

Pradhan Mantri Kaushal Vikas Yojana (PMKVY) is the flagship scheme of the Ministry of Skill Development and Entrepreneurship. The objective of this Skill Certification Scheme is to enable a large number of Indian youths to take up industry-relevant skill training that will help them in securing a better livelihood and to meet their employment as well as self-employment requirement. Besides these initiatives, flagship programmes of the Government such as Make in India, Digital India, Swachh Bharat Mission, Smart City Mission, Atal Mission for Rejuvenation and Urban Transformation, Housing for All, Infrastructure development and Industrial corridors have the potential to generate productive employment opportunities. The Centre has implemented the National Career Service Project which comprises a digital portal that provides a nation-wide online platform for the job seekers and employers for job-matching in a dynamic, efficient and responsive manner.

Prime Minister - SVANidhi Scheme: The Government has launched PM--SVA Nidhi Scheme to facilitate collateral free working capital loan up to 10,000 rupees of one-year tenure, to approximately, 50 lakh street vendors, to resume their businesses. In addition, RBI and Government of India have introduced measures to infuse liquidity in the economy to sustain the market economy and raise the level of employment.

Atal Beemit Vyakti Kalyan Yojana of the ESI Corporation provides relief in the form of cash compensation to Insured Persons in the contingency of their unemployment. The Labour Ministry has directed the State Welfare Boards not to distribute articles and household items to the workers and instead provide monetary assistance through Direct Benefit Transfer (DBT) into the workers' bank accounts. Transfer of money in the form of cash has been completely stopped by the

instant order and any monetary assistance has to be necessarily given through DBT. The order also puts a ban on the distribution of articles in kind. It mentions that no benefit can be provided in-kind except in extra-ordinary circumstances such as natural calamities, epidemics, fire, accidents caused due to occupational hazard or similar other crisis and only with the prior approval of the State Government. The Labour Ministry has issued an advisory on 24th of March 2020 to all states to provide financial assistance to the affected BOC workers via DBT from the welfare fund maintained by them. Most State Welfare Boards gave out grants ranging between one thousand to six thousand rupees to the registered workers. As per the latest figures, 5618 crore rupees were disbursed by the State Welfare Boards to about 1.83 crore construction workers directly into their bank accounts through DBT.

As per the Periodic Labour Force Survey carried out by the National Sample Survey Organisation of the Ministry of Statistics & Programme Implementation, in the year 2017-18, the total employment in both organized and unorganised sector in the country was around 47 crores. Out of this, around 9 crores are engaged in the organized sector and the balance of 38 crores in the unorganized sector. The workers have been divided into three categories like -- establishments with 10 or more workers, establishments with 20 or more workers and workers engaged in unorganized sector. The ESI Act, 1948 is a Social Security legislation applicable to all factories and notified establishments employing ten or more persons which are located in ESI notified areas and as such it does not apply to the unorganised sector. Employees earning wages up to 21,000 rupees per month, 25,000 rupees in the case of persons with disability are coverable under ESI Scheme and are entitled to all benefits available under ESI Act, 1948. At present the ESI Scheme stands extended to 575 districts in 35 States/ Union territories. The total number of Insured Persons covered under ESI Scheme as on 31st of March 2020 are 3.41 crore and the total beneficiaries are 13.24 crore. The benefits of social security to the workers employed in organised sector establishments with 20 or more workers under the Employees' Provident Fund and Miscellaneous Provisions Act, 1952 are extended through the three schemes --The Employees' Provident Funds Scheme, 1952; The Employees' Pension Scheme, 1995 and The Employees' Deposit Linked Insurance Scheme, 1976. The Employer and the Employee, both contribute at the rate of 12 per cent of wages towards Provident Fund. Out of this, 8.33 per cent is diverted towards Pension Fund. During the year 2019-20, a total of 4.89 crore members contributed under the Scheme. For the workers engaged in the unorganised sector, social security benefits are being addressed through the Unorganised Workers' Social Security Act, 2008. It empowers the Centre to provide Social Security benefits to unorganised sector workers by formulating suitable welfare schemes on matters relating to life and disability cover,

health and maternity benefits, old age protection and any other benefit as may be determined by the Centre. The States were also empowered to formulate suitable welfare schemes regarding housing, provident funds, educational schemes, skill upgradation, old age homes etc. Life and disability cover is provided through Pradhan Mantri Jeevan Jyoti Yojana and Pradhan Mantri Suraksha Bima Yojana. Benefits under the schemes are for 2 lakh rupees on death due to any cause and permanent disability, one lakh rupees on partial disability and 4 lakh rupees on death due to accident to the unorganised workers. As on 30th of December 2020, a total of 9.70 crore people were enrolled under the PM Jeevan Jyoti Bima Yojana and 21.87 crore under the PM Suraksha Bima Yojana.

Ayushman Bharat Scheme: The health and maternity benefits are addressed through Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana which is a universal health scheme administered by the National Health Authority. The number of eligible beneficiaries under Social Economic Caste Census of 2011 on the basis of select deprivation and occupational criteria across rural and urban areas is 10.74 crore families comprising 50 the Ayushman Bharat scheme have further expanded the coverage of the scheme to include families covering 65 crore people.

Pradhan Mantri Shram Yogi Maan Dhan Yojana: For old age protection to unorganised sector workers including traders, shopkeepers and self-employed persons, the Government has launched two flagship schemes namely Pradhan Mantri Shram Yogi Maan-Dhan Yojana (PM-SYM) and National Pension Scheme for Traders, Shopkeeper and Self-Employed Persons (NPS-Traders). Under the schemes, beneficiaries are entitled to receive minimum monthly assured pension of 3,000 rupees after attaining the age of 60. The workers in the age group of 18-40 years whose monthly income is below 15,000 rupees can join the PM-SYM scheme and Traders, shopkeepers and self-employed persons whose annual turnover is not exceeding 1.5 crore rupees can join NPS - Traders scheme. These are voluntary and contributory pension schemes and monthly contribution ranges from 55 to 200 rupees depending upon the entry age of the beneficiary. Under both the schemes, 50 per cent monthly contribution is payable by the beneficiary and equal matching contribution is paid by the Centre. Both the schemes are being implemented in all the States and Union Territories in the country. As on 28th of February 2021, about 44.90 lakh people were benefited under the Pradhan Mantri Shram Yogi Maan Dhan Yojana and 43,700 traders under the National Pension Scheme.

Atal Bimit Vyakti Kalyan Yojana: The Atal Beemit Vyakti Kalyan Yojana was introduced by the Employees' State Insurance Corporation on pilot basis for a period of 2 years effective from 1st of July 2018 for providing relief to the Insured Persons who have become unemployed. Under this scheme, relief in the form of cash compensation to the extent of 25 per cent of the average per day earning was paid upto a maximum of 90 days of unemployment subject to conditions that

the employee should have completed two years of Insurable employment and has contributed not less than seventy-eight days in each of the four consecutive contribution periods immediately preceding to the claim of the relief. Since its inception till 18th of March 2021, a total of 43,299 beneficiaries have availed relief under the scheme and an amount of 57.18 crore rupees has been disbursed. The scheme has been extended for the period from July 2020 to June 2021. In order to provide benefit to the insured persons who have become unemployed during Covid-19 pandemic, the rate of relief has been enhanced and the eligibility conditions have been relaxed for those who became unemployed from 24th of March 2020 onwards. According to the Statistics Ministry of Statistics during April to December, 2020, there is an addition of around 9.27 lakh female subscribers under the EPF Scheme, 1.13 lakh female subscribers under the New Pension Scheme and around 2.03 lakh female subscribers under Employees' State Insurance Scheme. Despite Covid-19 pandemic, EPFO added around 62.49 lakh subscribers during the current financial year.

Prime Minister's Employment Generation Programme: The Ministry of Micro, Small and Medium Enterprises (MSME) is implementing Prime Minister's Employment Generation Program, which is a major credit-linked subsidy programme aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector by helping traditional artisans and unemployed youth.

Working Conditions of Journalists: The Working Journalists and Other Newspaper Employees (Conditions of Service) and Miscellaneous Provisions Act, 1955, covers under its ambit conditions of employment and regulation of the service conditions of Working Journalists and also for Non-Journalists Newspaper Employees. The Working Journalists and Other Newspaper Employees (Conditions of Service) and Miscellaneous Provisions Act addresses the issues of hours of work, leave fixation and revising rates of wages which includes the constitution of a Wage Board. Further, the Information and Broadcasting Ministry implements "Journalist Welfare Scheme" to provide one time ex-gratia relief on urgent basis to journalists or their families under extreme hardship or on account of death of journalists and also to the journalists in case of permanent disability, major ailments and in case of accidents causing serious injuries necessitating hospitalization.

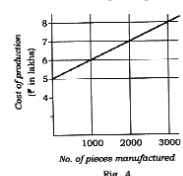

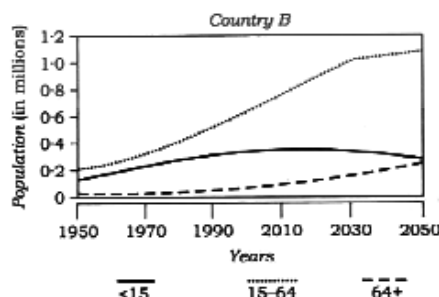
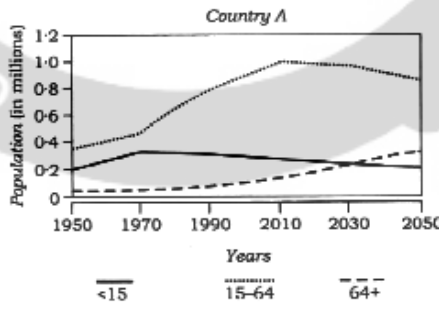

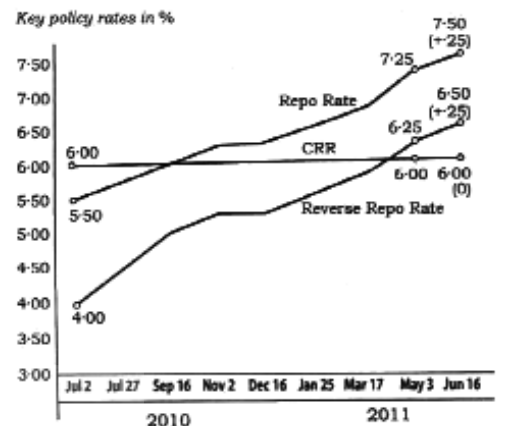

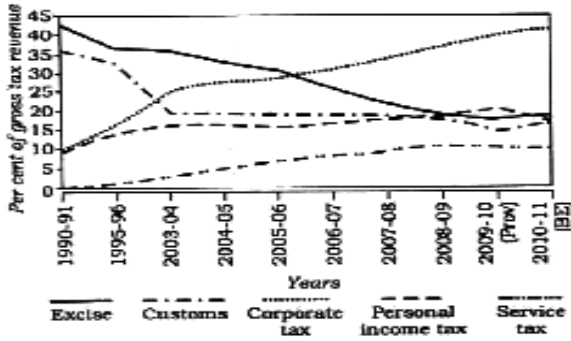

BOOSTING EMPLOYMENT ACROSS SECTORS

Statistics and Programme Implementation, the estimated Female Unemployment Rate on usual status for 15 years and above in the country is 5.6 per cent and 5.1 per cent respectively. The government has taken several initiatives to improve women's participation in the labour force. In order to encourage their employment, a number of protective provisions have been incorporated in the labour laws for creating congenial work environment for women workers.

Employment opportunities in Agriculture and Tourism sectors: The government supports and facilitates development and progress of Agriculture sector through various Centrally Sponsored and Central Sector Schemes. All the schemes are targeted for benefiting farmers and increasing their livelihood opportunities by promoting agro-based employment. Ministry of Agriculture & Farmers Welfare has introduced a new component called Innovation and Agri-Entrepreneurship component under Rashtriya Krishi Vikas Yojana-Remunerative Approaches for Agriculture and Allied sector Rejuvenation with the objective to generate employment by promoting start-ups in agriculture and allied sector. Government is also promoting agro-based business through Venture Capital Assistance Scheme through Small Farmers

Agribusiness Consortium. Under the scheme assistance in the form of interest free loan is extended up to 26% of the promoter's equity or 50 lakh rupees to agripreneurs whichever is lower for projects upto 500 lakh rupees.

Ministry of Tourism has taken several steps over the years to give boost to the tourism sector in the country and in turn generate employment opportunities like Swadesh Darshan Scheme with a vision to develop theme based tourist circuits, National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD) Scheme for holistic development of identified pilgrimage destinations, Heritage Project for development and maintenance of tourist amenities at heritage sites, monuments and other tourist sites and Incredible India Tourist Facilitator Programme etc. The Pradhan Mantri Mudra Yojana (PMMY) has been initiated by Government inter alia, for facilitating self-employment. Under PMMY collateral free loans upto 10 lakh rupees are extended to micro, small business enterprises and individuals to enable them to setup or expand their business activities.

PREPARING FOR CIVIL SERVICES INTERVIEW

past several years makes it easier to anticipate what questions you are likely to be asked in your interview. Of course not all the areas or questions can be predicted as there will always be some unpredictable questions. To be realistic, you should prepare for predictable questions and not the unpredictable ones. In any case, as far as unpredictable questions are concerned, even if you are not able to answer some of them, its not going to impact your interview so long as you are strong enough in the predictable part of the questions. Some of the probable questions will be on the following topics.

1. DAF: You are required to furnish in your DAF a variety of

details regarding your parental, educational background, your job description if any, your hobbies and extracurricular activities, choice of services and preference for cadre. Thus, your DAF attracts the members most and they form an opinion about you through your DAF, raise questions on the basis of information furnished by you in it. Be very careful to furnish those information with accuracy and honesty. Never commit yourself to anything in DAF which is difficult to defend or justify. Since you have on your provided those information, you are supposed to defend them. Consult some knowledgeable persons to formulate your answers on DAF.

2. Your state: Questions on

your state relating to its economy, law and order, issues of governance, culture, history etc are bound to crop up. A quick brush up on these issues from authentic sources is highly desirable. For example, if you belong to Bihar, its history in terms of big empires like Mauryan empire, birth of Buddhism, Jainism may be asked. Bihar's backwardness, caste ridden politics, bad governance will be taken up by the board members during the conversation and your views will be elicited on the same. Recent issues like impact of prohibition, recently passed Bihar Police Act will surely be asked. Taking a cue from this example, you should prepare for your respective states.

3. National issues: This will be an important part of the interview conversation. Covid related health issues, governance challenges posed by covid, measures being taken to revive the economy, farm bills and issue of protests, downgrading of Indian democracy by international watchdogs, rise in naxal violence, and a host of other recent issues will be on the plate.

4. International issues: A lot has happened on the international horizon in the last several months. China related issues, US elections, JCPAO and Iran, cyber attacks by China and Israel, Abraham accords, vaccine diplomacy, role of WHO during pandemic, Brexit and its implications for UK, EU and India, Indian foreign policy and its relationship with neighbours, especially

recent disengagement on LAC between India and China, ceasefire on LOC between India and Pakistan, trade issues with Pakistan, Indo-Nepal issues, 50 years of Bangladesh independence, devolution of powers in Sri Lanka etc are going to be some of the areas on which questions will be raised. One should list out several more such issues and formulate different questions/answers on these issues.

5. Controversial questions: Candidates always wonder as to what stand to take on controversial issues. For example, how to answer questions on farm laws which are so controversial, or, what stand to take on the reservation politics. On such issues, a rebellious, extreme type of stand should be avoided. Middle path should be chosen by adopting moderate opinions. You may disagree with government stand on an issue but never sound politically opposed or motivated because you are supposed to be neutral and unbiased as a civil servant. The key here is to make a list of

controversial issues, frame probable questions and articulate a stand beforehand so that you don't have to improvise it during interview.

While answering questions on the above issues, you must sound authentic, and well informed. You must appear to be in possession of a critical, analytical mind with keen interest on issues of public importance. Even if you don't have in-depth knowledge of the subject, its fundamentals should be clear to you.

6. Your optional paper: The board will get to know about your optional paper from your DAF. They may or may not test you on your optional paper but you must anticipate a few questions and prepare their answers. Usually, the questions on the optional paper are not specialised but of a general nature. They may want to know why you have opted for it, its application in administration, current developments in the subject, if any.

Finally, just preparing on the expected areas is not the complete preparation for the interview. Its about projection of your true, authentic and real personality. Therefore, try to reveal the real attributes of a good personality during the interview session. Remember, interview session is not an extraordinary event. There will be no extraordinary expectations from you by the board members. It is going to be just a normal dialogue between you and the members in a comfortable atmosphere. So, no need to act before the board as someone which you are not. Present your normal self rather than trying to impress the board by over projection of your personality.

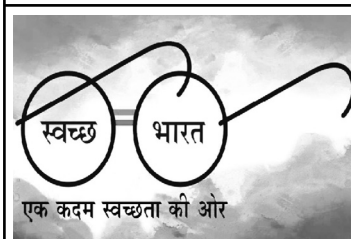

VIRTUAL BOOK FAIR : PROMOTING READING HABITS

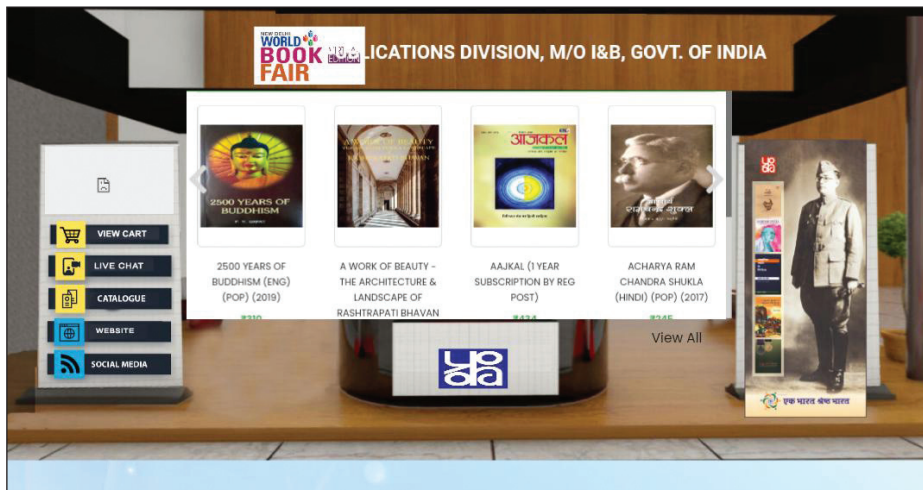
The fascinating world of books was in sharp focus recently with the online edition of New Delhi World Book Fair 2021. The fair is organized every year by the National Book Trust.

Q1) Tell us about the challenges of organising a virtual book fair in these times of the Corona pandemic.

No event such as the scale of the New Delhi World Book Fair can be organised sans challenges. Yet, with the right motivation, all challenges can be overcome. Keeping in mind the pandemic-induced restrictions, the Fair was organised on a virtual platform this year. We had the support from the best IT and virtual exhibition platform teams, and we work with them to make the visit of the exhibitors and the visitors a smooth ride.

Q2) How easy was it for book lovers to flip through and buy books online?

It was a 3D platform having a complete 360 degree experience. We gave it the feel of a real fair, with the ease of browsing and buying books, e-visiting stalls, e-meeting exhibitors, along with the regular NDWBF literary events, activities of children, Theme Pavilion, etc. The visitors were able to view the books on display, as well as have access to exhibitors' catalogues.

of book lovers is rising year per year. Social media and internet has in fact aided the publishing industry. Books have become so easily accessible that a reader has to just go to the online store and purchase a book that get delivered within a day or so. The internet actually facilitates further discussions on books by connecting like-minded people from different corners of the world.

Q4) Despite the availability of e-books, the pleasure of holding a physical book in the hand is priceless. Do you plan to encash this psychological behaviour and habit?

The joy a reader gets from reading a physical book cannot be received from any other format. At the same time, it would be unwise to also ignore the increasing trend of e-books, audio books, etc. as long as people need knowledge and need stories, books in any format, will always be in demand.

Q5) Catch them young is the buzz phrase. Does NBT have a strategy to target school and college going readers?

Phase III of COVID-19 vaccination begins from May 1 for everyone above 18 years of age

Everyone above the age of 18 years will now be administered COVID-19 vaccine from the 1st of May. The Central Government announced a liberalised and accelerated phase-three strategy of Covid-19 Vaccination. A decision in this regard was taken during a meeting



chaired by Prime Minister Narendra Modi. The registration process for COVID vaccination to all above 18 years will start from 28th of this month. All those eligible can register on Co-Win portal - cowin.gov.in. Vaccination will continue as before in the Government vaccination centres free of cost to the eligible population including Health Care Workers, Front Line Workers and all people above 45 years of age. In phase three, vaccine manufacturers will supply 50 percent of their monthly released doses to the Central Government and they will be free to supply the remaining 50 percent doses to States as well as in the open market. Private Hospitals will have to procure their supplies of Covid-19 vaccine exclusively from the 50 percent supply earmarked for other than the Central Government channel. The Central Government from its share, will allocate vaccines to States and Union Territories based on the criteria of the extent of infection and the speed of administration. All vaccination will be part of the National Vaccination Programme and mandated to follow all protocol such as being captured on CoWIN platform.

FM urges industry to wait & watch for next few days to assess situation amid 2nd wave of COVID-19

Finance Minister Nirmala Sitharaman has urged the industry to wait and watch for next few days to assess the situation amid the second wave of COVID-19 pandemic and assured them of full government support. She was addressing the FICCI National Executive Committee Members through virtual mode. Speaking on the oxygen supply, Ms Sitharaman

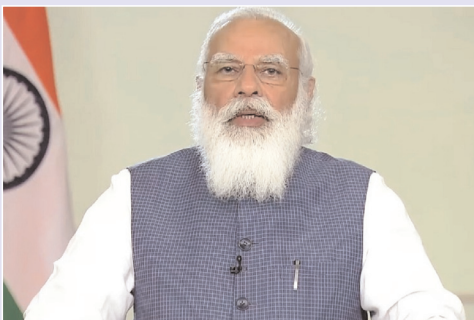


said that the supply has been very neatly mapped and new permissions have been given particularly for the hard stressed 12 states. She said, the government has exempted all inter-state movement of oxygen tankers, exempted from registration and permits and they can operate round the clock. She said, cylinder filling plants are operating 24 hours to fill the gaps with necessary safeguards. She stated that steps have been taken adequately for drugs which are important and the government has given fast-track approvals for Remdesvir production. The Finance Minister also said that as soon as the medical oxygen demand will be met, the industry would also get the necessary supply of oxygen since the import of medical oxygen has been allowed.

The Prime Minister said, India welcomes partners to create templates of sustainable development in India. He said, these can also help other developing countries, who need affordable access to green finance and clean technologies. Mr Modi said, he

CAG GC Murmu chosen as external auditor by OPCW

Comptroller and Auditor General (CAG) of India, GC Murmu, has been chosen as the external auditor by a prestigious inter-governmental organisation working for the elimination of chemical weapons. The Hague-based Conference of State Parties of the Organisation for the Prohibition of Chemical Weapons (OPCW) selected the CAG as its external auditor for a three-year term starting 2021. The External Affairs Ministry said India's election was a recognition of its standing among the international community as well as the professionalism, high standards, experience globally and competitive bid by the CAG of India. India was also selected as a member of the Executive Council of the OPCW representing Asia Group for another two-year term during the OPCW Conference of State Parties.

ECONOMIC

Export of Agricultural and allied products register 18.5 percent increase

India has witnessed an impressive increase of almost 18.5 percent in export of Agricultural and allied products during April 2020 to February 2021 as compared to the same period, the previous year. The country had witnessed tremendous growth of 727 percent in Wheat export and 132 percent in Non-Basmati Rice export, despite the prevalence of Covid-19 pandemic.



India took care not to disturb the world food supply chain and continued to export even during the pandemic. The export of Agricultural and allied commodities during April 2020 to February 2021 was over 2 lakh 70 thousand crore rupees. The imports of Agricultural and allied commodities during this period witnessed a slight increase of 2.93 percent. During this period, despite COVID-19, the balance of trade in agriculture has favourably increased.

Mirabai Chanu creates a new Clean and Jerk world record in Asian Weightlifting Championships

India's Mirabai Chanu set a new World Record in the women's 49 kg Clean and Jerk with an impressive 119 kg lift at Asian Weightlifting Championships in Tashkent. The 26-year-old lifted 86 kg in snatch and a world record of 119 kg in clean and jerk for a total of 205 kg which also won her the bronze medal at the event on April 21. The gold medal went to HouZhihui of China who created a new world record in snatch and total weight with an effort of 213 kg while her compatriot Jiang Huihua clinched the silver, lifting 207 kg in the gold level Olympic qualifier.

Deepak Punia settles for silver in 68kg at Asian Championships

World championships silver medallist Deepak Punia had to settle for silver medal in the Asian wrestling championships in Almaty, Kazakhstan on April 21. Deepak, who has already secured a place in Olympics, lost 10-0 in two minutes 53 seconds to the world champion Hassan Yazdani in the 86kg freestyle final. Sanjeet bagged bronze for India in the 92 kg category. He lost to Uzbekistan's RustamShodiev 8-11. India thus ended the Asian Championships with seven medals in the men's freestyle event and an overall tally of five gold, three silver and six bronze medals.

India Open Badminton Tournament 2021 stands postponed

India Open badminton tournament 2021 has been postponed in the wake of a sudden rise in the COVID-19 cases in New Delhi. The tournament was scheduled to be held at the KD Jadhav Indoor Hall in New Delhi from May 11-16. In an emergency discussion held with Badminton World Federation (BWF), Badminton Association of India (BAI) decided to postpone the upcoming Yonex-Sunrise India Open 2021. The BWF World Tour Super 500 tournament was classified as one of the last few qualification tournaments for the Tokyo Olympics and had attracted top players including Kenta Momota, Victor Axelsen and several other Top-10 players along with representation from 33 countries.
