The undersigned is directed to refer to this Ministry's letter No. 17(01)/2017(02)/D(Pension/Policy) dated 17.10.2018, issuing Concordance Table to facilitate fixation of notional pay in respect of pre-2016 Armed Force pensioners/family pensioners who retired/died prior to 01.01.2016.

2. An error has been noticed in Concordance Table of Lt. General (HAG) of AMC/ADC/RVC in pay matrix level 15 already issued. Further, it has also been observed that Concordance Table for Lt. General (HAG+) of AMC/ADC/RVC in pay matrix level 16 was not prepared and issued.

3. In view of the above, Concordance Table for Lt. General (HAG+) of AMC/ADC/RVC in pay matrix level 16 and modified Concordance Table in respect of Lt. General (HAG) of AMC/ADC/RVC in pay matrix level 15 in lieu of the Concordance Table already issued, have now been prepared and are enclosed (Annexure A) herewith.

4. Due care has been taken to prepare these concordance tables based on the fitment tables for fixation of pay. However, in case of any inconsistency in the Concordance tables vis-a vis the relevant rules/instructions, the notional pay and pension/family pension of pre-01.01.2016 pensioners/family pensioners may be fixed in



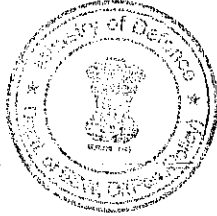


